- 1-18-17 Perf @ 1995', unable to establish rate, RIH to 2050', spot a 40 sx plug. WOC. RIH to tag plug, no tag. Pump a 50 sx plug @ 2050, WOC.
- 1-19-17 Tag plug @ 1675'. Perf @ 875', unable to establish rate. RIH to 925' and spot a 30 sx plug. WOC and tag plug 760'. Perf every 50' from 450' to surface, per Jim Hughes instructions. Pump 125 sx to surface.
- 1-26-17 Cut well head off 3 BGL, weld steel plate and dry hole marker.
