Each well will have an individual EFM regularly calibrated to API, NMOCD, and BLM specifications located near the separation equipment. The gas production from the wells listed above will be measured, commingled, and sold off lease using the well test method.

Process and Flow Descriptions:

An Enterprise common gas sales meter (68723-01) is located in Sec.33, T19S, R29E. This meter is calibrated on a regular basis per API, NMOCD, and BLM specifications.

The commingling of production is in the interest of conservation and waste and will result in the most effective economic means of producing the reserves in place from the affected wells and will not result in reduced royalty or improper measurement of production. The proposed commingling will reduce operating expenses as well as reduce the surface facility footprint and overall emissions.


