Mack Energy proposes to lay (4) 10" lay flat surface lines from our Round Tank Pit to our Prince Rupert Federal 3H location. Total Distance of these lines will be 7425' in length. Lines will carry 85,000 bbls of produced water from our frac pit to location for the purpose of fracing the Prince Rupert Federal 3H. Anticipated frac dates are 3/20-3/24/2017. We ask for a 30 day window to allow for schedule conflicts. These lines will be laid on the surface along side of the existing road, within 2' of the roads edge. There will be a portion laid down ROW NM-136416 to location.


