Lime Rock has recompleted this Yeso oil well to the San Andres as follows: On 3/14/17, MIRUSU. TOH w/rods, pump, & tbg. Set a 5-1/2" CBP @ 2490' & PT 5-1/2" csg & CBP to 4000 psi-OK. (Existing Yeso perms are @ 2553'-3939'). Perfed San Andres @ 2060'-2405' w/35-0.4" holes. Stimulated with 1500 gal 15% HCL acid & fraced w/~30,000# 100 mesh & 346,380# 40/70 Ottawa sand in slick water.

CO after frac to CBP @ 2490'. Landed 2-7/8" 6.5# L-80 production tbg @ 2357'. Ran pump & rods. Released workover rig on 3/30/17. Completed as a single San Andres oil well. After production decreases CBP @ 2490' will be removed and the well downhole commingled as per State order DHC-4808.
