Spudded well on 1/26/17. Drilled 12-1/4" hole to 350'. Set 8-5/8" 24# J-55 csg @ 350'. Cmted w/300 sx (402 cf) cl "C" cmt w/2% Cacl2, & 0.125#/sx cello flakes. Circ. 105 sx cmt to surface. On 1/27/17, pressure tested 8-5/8" csg to 1500 psi for 30 min-OK.

Drilled 7-7/8" hole to TD4510' on 2/1/17. Open hole logs hit bridge @ 912', so did not run. On 2/1/17, set 5-1/2" 17# J-55 production csg @ 4498'. Cmted lead w/300 sx (588 cf) 35/65 poz cl "C" w/6% gel/PF20, 5% salt/PF44, 0.2% fluid loss/PF606, 0.25#/sx cello flake/PF29, 0.4#/sx antifoamer/PF45, 0.1% retarder/PF13 & 3#/sx kolseal/PF42. Tailed w/600 sx (798 cf) cl "C" cmt w/0.2% fluid loss/PF606, 0.2% dispersant/PF65, 0.1% retarder/PF13 & 0.125#/sx cellophane/PF29. Circ 40 sx cmt to pit. Released drilling rig on 1/25/17. Plan to pressure test 5-1/2" csg during
