1. That he is President of E. G. L. Resources, Inc.

2. That E. G. L. Resources, Inc. is the operator of a well drilled on land belonging to

Runyan/Martin 4 Mile Ranch, LLC, whose address is PO Box 1414, Hope, NM 88250,

said well being plugged and abandoned and described as the


Runyan "30" State Com. No. 1, being located 990 feet from the  
South line and 1,980 feet from the West line of Section 30  
Township 19-S, Range 23-E, NMPM, Eddy County, New Mexico.

3. That said well was drilled to a total depth of 8,050 feet, and that casing has been set and cemented as follows:  
13-3/8", 54.5 #/ft, K-55 ST&C casing set @ 317 feet. Cement w/ 400 sxs. Topped out w/ 8 yards @ surface.  
8-5/8", 24 #/ft, K-55, ST&C casing set at 1,595'. Cemented w/ 1,100 sxs cement. Circulated 400 sxs to surface.  
4-1/2", 11.6 #/ft, K-55, LT&C casing set at 8,025'. Cemented w/ 950 sxs cement. TOC @ 5,224' by Temp. Surv.

4. That operator and landowner have made an agreement whereby the landowner is responsible to complete plugging the well when he is finished using it for a water well, back fill pits, level location, and clear it of all junk. The agreement further provides that the operator is to plug said well back to a plugged-back total depth of 1,550 feet and transfer well to landowner for his use as a water well. Operator will address pit are and meter run where vegetation has not regrown. Operator will leave casing in the well as follows:

13-3/8", 54.5 #/ft, K-55 ST&C casing set @ 317 feet. Cement w/ 400 sxs. Topped out w/ 8 yards @ surface.  
8-5/8", 24 #/ft, K-55, ST&C casing set at 1,595'. Cemented w/ 1,100 sxs cement. Circulated 400 sxs to surface.  
4-1/2", 11.6 #/ft, K-55, LT&C casing set at 8,025'. Cemented w/ 950 sxs cement. TOC @ 5,224' by Temp. Surv.

5. That when operator has complied with the provisions of Paragraph 4 above, it will so notify the Oil Conservation Division of the State of New Mexico on Form C-103, together with a signed statement from the landowner that the provisions of Paragraph 4 above have been complied with to his satisfaction.
