EOG Y Resources, Inc. is in the process of evaluating equipment at each of our well sites in order to obtain an accurate physical inventory, and we plan on having the field site audits completed by December 31, 2017. This location currently has out of service equipment present and will be evaluated during the audit process. This location is an economical well, but production of the well has been curtailed due to restraints at the Lucid Energy processing plant in Chaves County because of nitrogen issues. Currently, we produce this well on an average of one day each month. If Lucid Energy were to address and correct the nitrogen issue we would be able to produce this well on a regular basis, and we would then need the equipment present for production purposes. If at the time of the audit it is determined that the equipment is no longer needed at the site, we will notify BLM and begin the process to remove the equipment and haul it to a storage yard. If it is determined that this equipment needs to remain at the site, we will send in a sundry requesting that BLM allow us to keep this equipment at the site. We will have the additional sundry submitted
