Surface restoration is complete and ready for inspection. The following corrective actions were performed: The contaminated soil was removed from the well pad area, placed in the pit area and covered with liner, caliche and clean top soil as described below. A 1' trench was dug 10'-15' outside the pit area and woody vegetation and sharp objects were removed. A 220'x220', 20 mil liner was placed on top of pit area and covered with 1.5' to 2' of caliche as an anchor to liner. Clean top soil was used to fill in where material was removed and 1.5' to 2' of clean top soil was placed over the entire pit area. The top soil was feathered out to blend and cover the natural gyp site to the north of pad and pit area. The area was seeded with the Pecos District Desired Plant Community seed mixture for the Gyp Upland SD-3 Ecological Site. A 2' x 400' berm was built along the road to stop traffic to the location.
