Plug down @ 5:30 P.M. 07/01/17. Circ 180 sks cement to pit. WOC 8 hrs. Tested BOPE to 5000# & Annular to 3500#. At 3:45 P.M. 07/02/17, tested csg to 1500# for 30 minutes, held OK. Drilled out with 12 1/4" bit. FIT test to EMW of 10.0 PPG.
