06/15/17 Set 5 1/2" CIBP @ 1675'. Circulated hole w/ mud laden fluid. Pressure tested csg, held 500 psi. Spotted 25 sx class C cmt @ 1675-1428'. Perf'd csg @ 930. Sqz'd 45 sx class C cmt @ 930 & displaced to 830'. Pressured up to 1300 psi. Shut in for 2 hours. Perf'd csg @ 395'. Sqz'd 126 sx class C cmt @ 395' & circulated to surface.
