Devon Energy respectfully requests to carry out batch drilling operations on the Cotton Draw Unit 293H, 291H and the 513H.

- Surface casing has been pre-set so the drilling rig will rig up over the respective well and will batch drill the intermediate sections with saturated brine and run/cement intermediate casing; the wellbore will be isolated with a blind flange and pressure gauge installed for monitoring the well before walking to the next well.
- The drilling rig will then batch drill the production hole sections on the wells with cut brine, run/cement production casing, and install TA caps or tubing heads for completions.
