THE WELL IS A SALT WATER DISPOSAL WITH AN INJECTION RATE OF 200-300 BWPD. SHUT IN STATUS OF 6 MONTHS THROUGH JANUARY 2018 IS REQUESTED, PENDING THE COMPLETION OF AN ENGINEERING AND GEOLOGICAL REVIEW TO ASSESS THE FEASIBILITY AND OPTIONS OF CONTINUED BENEFICIAL USE FOR THIS WELL. AN ADDITIONAL SUNDRY 3160-5 SUNDRY NOTICE OF INTENT WILL THEN BE SUBMITTED ADVISING OF THE PREFERRED OPTION FORWARD.
