Well is on OCD inactive well list. Rockcliff Operating New Mexico submitted a NOI to recomplete this well and another well on the same lease (Teledyne 12 Federal #3) earlier this year. The Teledyne 12 Federal #3 was recompleted and initially showed oil production, however the amount of oil produced is not enough to make this well economic at the current oil price. Due to the fact that the recompletion on the Teledyne 12 Federal #1 was planned to be very similar to the Teledyne 12 Federal #3, Rockcliff Operating New Mexico LLC is requesting the option to TA both of these wells until a more economic climate exists.

Proposed TA Procedure: Set CIBP within 100' of uppermost perforations (currently 4,757'), fill with inert fluid, and pressure test to 500 psi with a pressure drop of not more than 10% over a 30 minute period.
