09/26-09/27/2017: MIRUPU, POOH w/ 83 3/4" rods and pump. Pull rod is parted. Close well in and SION.  
 09/27-9/28/2017: POOH w/ 2 3/8" tbg. RIH w/ 68 jnts tbg, SN and MJ, open ended. RIH w/ rods, POOH 83- 3/4" rods, close well in with valve. Well is prepared for plugging, RDPUMO.

10/24-10/25/2017: MIRUPU and plugging equipment. Run gauge ring and junk basket. Set CIBP @ 2050', RDWL, pick up and RIH with work string. Close well in and SION.  
 10/25-10/26/2017: RU and circulate 30 bbls brine mud, mix and spot 15 sks Class C cement from 2050' – 1833'. WOC and tag with WL @ 1833'. Mix and spot 20 sks Class C cement from 700' – 480'. WOC and tag @ 468subsequent'. Perf @ 429', squeeze 40 sks Class C cement. WOC and tag in the AM. Close well in and SION.  
 10/26-10/27/2017: RIH with WL, Tag @ TOC 312'. NMOCD said to perf and squeeze. Perforated @ 310'. Attempt to get injection rate, csg pressure up to 700#. NMOCD said spot cement @ 30' to surface. Mix and spot 5 sks Class C cement from 30' to surface. No fall back. RD and move out plugging equipment.
