Set 5-1/2" CBP @ 3900'. PT 5-1/2" csg & CBP to 4500 psi-OK. Perfed Yeso @ 3380'-3761' w/39 holes. Treated perfs w/1000 gal 15% HCL acid & fraced w/30,351# 100 mesh & 351,008# 30/50 sand in slick water. Spotted 500 gal 15% HCL over next stage.
