SHUT IN STATUS OF 6 MONTHS THROUGH APRIL 2018 IS REQUESTED, PENDING THE COMPLETION OF AN ENGINEERING AND GEOLOGICAL REVIEW TO ASSESS THE FEASABILITY AND OPTIONS OF CONTINUED BENEFICIAL USE FOR THIS WELL. AN ADDITIONAL SUNDRY 3160-5 NOTICE OF INTENT WILL THEN BE SUBMITTED ADVISING OF THE PREFERRED OPTION FORWARD. IF YOU HAVE ANY QUESTIONS.
