TOC ~6550'. For second stage, performed Bradenhead squeeze by pumping 10 BBLs tuned spacer then cementing w/ 980 sks (301 BBLs) PPC w/ additives, 13.5 PPG, 1.73 yield. TOC @ 1624' ND BQR and install night cap.
