Calc top of cmt = 6340'. For second stage, performed Bradenhead squeeze from surface w/ 910 sks (304 BBLs) PPC w/ additives, 12.9 PPG, 1.87 yield. Ran echometer, TOC = 1090'. Performed remedial cmt job w/ 148 sks (35 BBLs) PPC w/ additives 14.8 PPG, 1.33 yield. Circ. 2 BBLs (9 sks) to surface. ND BOP, Install night cap.
