12/4/17 - MIRU. Bled well off. Unseat pump and POOH with production equipment. Pumped 40 bbls fresh water down 5-1/2 inch casing and NU BOP. Set a 5-1/2 inch CIBP at 2220 ft.
12/5/17 - Ran gyro survey. Tagged CIBP. Pumped 15 bbls plugging mud. Spotted 25 sx Class C cement on top of CIBP to 1975 ft calc TOC. WOC. Tagged TOC at 1977 ft. Pumped 75 bbls plugging mud. Spotted 25 sx Class C cement from 1916 ft - 1671 ft calc TOC.
12/6/17 - Perforated at 940 ft and 900 ft. Spotted 45 sx Class C cement from 1005 ft - 564 ft calc TOC. Circulating out 5-1/2 inch casing with 9-5/8 inch shut. Switch hoses and open 9-5/8 inch allowing plug to balance in and out.
12/7/17 - Tagged TOC at 738 ft. Perforated at 535 ft. Established rate down 5-1/2 inch and up 9-5/8 inch casing. ND BOP. Pumped 200 sx Class C cement up to surface.
12/14/17 - Cut off wellhead. Installed dry hole marker and cut off anchors. WELL IS PLUGGED AND ABANDONED.
