The Zach McCormick #201H will spud first. After drilling surface, 1st intermediate, and 2nd intermediate hole sections and cementing 2nd intermediate casing, the C-section will be installed with a 10M dry hold cap with bleed off valve. The rig will then walk over and spud the Zach McCormick #221H and drill this well through production casing and tubing head installation. At this point, the rig will walk back to the Zach McCormick #201H to drill the production hole.
