RIH & set 5-1/2" 20#, P110 DQX csg @ 20070', pump 100 BBLs spacer, then cmt w/ 308 sks (72 BBLs) PPC w/ additives, 13.2 PPG, 1.38 yield, followed by 2194 sks (514 BBLs), 13.2 PPG, 1.38 yield. Estimated TOC = 6500'. For second stage performed Bradenhead squeeze, pumping 50 BBLs FW, then cementing w/ 191 sks (43 BBLs) PPC w/ additives, 14.8 PPG, 1.33 yield, followed by 741 sks (245 BBLs) PPC w/ additives, 12.8 PPG, 1.76 yield, followed by 333 sks (76 BBLs) PPC w/ additives, 12.8 PPG, 1.76 yield. Ran echometer, TOC = 206'. ND BOP, install well cap, release rig (1/6/18).
