RIH w/ 9-5/8" 47# L80 BTC csg and set @ 4394', pump 20 BBLs MPE spacer, then cmt w/ 1220 sks (408 BBLs) PPC w/ additives, 12.9 PPG, 1.87 yield followed by 160 sks (38 BBLs) PPC w/ additives, 14.8 PPG, 1.33 yield. Circ. 118 BBLs to surface. BLM on location to witness cmt job. Pressure test csg to 4800 psi for 30 min, good test. Install pack-off, ND BOP, release rig (12/18/17).
