On 1/29/18, MIRUSU. TOH w/rods, pump, & tbg.. (Existing perfs are 44 holes @ 2450'-3422'). CO to 3721'. TOH. Perfed Yeso @ 3542'-3721' w/23 holes. Set 5-1/2" RBP @ 1500' & PT RBP & 5-1/2" csg to 500 psi-OK. Changed out wellhead. Retrieved RBP & TOH.
 Set 5-1/2" pkr on 3.5" 9.3# L-80 frac string @ 3501'. Frac string communicated w/back side during pad. Released PKR & TOH w/frac string. Perfed Yeso @ 3152'-3446' w/27 holes. Set 5-1/2" PKR @ 3132' on 3-1/2" 9.3# L-80 frac string. Treated perfs 3152'-3721' w/30,089# of 100 mesh & 147,760# 30/50 sand in slick water. Ran 1000# diverter w/150 bioballs. Continued treating perfs down frac string w/30,102# 100 mesh & 286,380# 30/50 sand in slick water. Found frac string & PKR stuck. Fished for 10 days to recover frac string & PKR.
 On 3/8/18, set 5-1/2" CBP @ 3110'. Perfed Yeso @ 2490'-3082' w/37 holes. Treated perfs down 5-1/2" csg w/1500 gal 15% HCL acid & fraced w/29,380# 100 mesh & 275,730# 30/50 sand in slick water.
