Pursuant to Rule 3 of the Special Rules for the Purple Sage-Wolfcamp Gas Pool and NMAC 19.15.15.11.B(2), RKI Exploration & Production, LLC ("RKI") (OGRID 246289) seeks administrative approval of a 160-acre non-standard spacing and proration unit comprised of the SE/4 of Section 4, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico. The proposed non-standard spacing and proration unit will be combined with a standard 320-acre spacing unit in the E/2 of Section 9 to form a 480-acre project area dedicated the following horizontal wells:

- Tucker Draw 9-4 Fed Com No. 1H
- Tucker Draw 9-4 Fed Com No. 2H
- Tucker Draw 9-4 Fed Com No. 3H
- Tucker Draw 9-4 Fed Com No. 4H
- Tucker Draw 9-4 Fed Com No. 5H
- Tucker Draw 9-4 Fed Com No. 6H
- Tucker Draw 9-4 Fed Com No. 7H

These wells will develop the Wolfcamp formation (Purple Sage; Wolfcamp Gas Pool (98220)). Pursuant to the Special Rules for the Purple Sage-Wolfcamp Gas Pool, set forth in Order No. R-14262, wells within the Purple Sage Pool must be spaced on 320-acres. Rule 3 of the Special Rules for Order R-14262 permit exceptions as allowed in Division rules. The Division rule 19.15.15.11.B(2) authorizes administrative approval of non-standard spacing units when the non-standard spacing unit consists of a single quarter-quarter section or lot or quarter-quarter sections or lots joined by a common side and the non-standard spacing unit lies wholly within a

single half section if the well is in a pool for which 320 acres is the standard spacing unit size. The proposed non-standard spacing unit consists of adjoining units and is located wholly within a single half-section.

RKI seeks approval of this non-standard spacing unit to most efficiently develop the Wolfcamp in this area. All interest owners within the proposed 480-acre project area, include the proposed non-standard spacing unit, have previously been made aware of RKI's development plan.

**Exhibit A** is a copy of the Well Location and Acreage Dedication Plat (Form C-102) for the seven proposed wells.

**Exhibit B** is a copy showing the proposed wells and the proposed spacing unit in the SE/4 of Section 4 and the E/2 of Section 9. Tracts 1 and 2 are the area affected by the administrative application.
