Spotted 40 sx class C cmt @ 1044-798'. WOC. 04/17/18 Tagged plug @ 850'. Perf'd csg @ 435', pressured up on perms to 600 psi. Spotted 25 sx class C cmt w/ 2% CACL @ 485-270'. WOC. Tagged plug @ 415'. Perf'd csg @ 60' (per BLM's approval), Pressured up on perms to 800 psi. Bled off pressure. ND BOP. Spotted 80 sx class C cmt @ 415' & circulated to surface. 04/18/18 Rigged down and moved off. Moved in backhoe and welder. Dug out cellar. Cut off well head. Verified cmt to surface. Welded on "Below Ground Dry Hole Marker". Backfilled cellar. Cut off deadmen. Cleaned location, moved off.
