As per your Sundry request the above well is Shut-in (SI). The Bureau of Land Management (BLM) definition of a shut-in well is a completion that is physically and mechanically capable of production in paying quantities or capable of service use. 43 CFR 3162.3-4 (C) requires that wells incapable of production in paying quantities be promptly plugged and abandoned and requires approval for any well temporarily abandoned for more than 30 days.

**Your Sundry Notice is being APPROVED.**

43 CFR 3162.4-1(c) also requires you to notify the Authorized officer, not later than the fifth business day after production is resumed for any well which has been off production for more than 90 days, the date on which such production was resumed.

2. This will be the last Shut-in approval for this well.
