

Water from the Poker Lake Unit 274 Battery is stored in fiberglass tanks on the location. Water is then transferred to the Poker Lake SWD system via pipeline. The Poker Lake Unit SWD system is a pressurized system. Water is routed to five (5) SWD wells on the Poker Lake Unit based on the pressure in the line at that time.
