 6/12/18 - Tagged CIBP. Circulated 30 bbls water. Pressure tested to 500 psi, held good. Spotted 90 sx Class "C" cement from 1257' up to surface. Topped off well with cement.
 7/10/18 - Cut off wellhead. Installed dry hole marker and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
