Plug down @ 8:00 AM 06/03/18. Displaced w/118 bbls BW. Cmt head blew off & unable to continue displacement. Circ 156 sks of cmt to the pits. Drilled out with 17 1/2" bit.

06/10/18..Spud 17 1/2" hole @ 2565'. Ran 2565' of 13 3/8" 54.5# J55 BT&C Csg. Cemented with 750 sks Class C w/additives. Mixed @ 12.0#/g w/ 2.54 yd. Tail w/200 sks Class C w/additives.
