The operator would like to amend the approved drilling permit as follows:

- Change 9 5/8" surface casing size: Drill 17 1/2" hole to 500' md and set 13 5/8" 48 ppf H40 STC csg, and cement w/ 525 sx class C cement to surface.
- Drill 12 1/2" pilot hole to 2500' md and run logs. Plug back pilot hole from 1900' to 1200' (700') w/ 680 sx class H slurry. WOC and dress off 200' of cement plug to 1400'.
- Drill 12 1/4" hole and run 9 5/8" intermediate casing: KO 8"/100' curve at 1400' w/ 12 1/4" hole and land at 2525' md (tvd of 2150' and 183° azimuth same as original permit plan). Run 9 5/8" 36 ppf J55 STC to TD and cement w/ 790 sx class C cement to surface.
- Run uncemented pkr and port completion: Drill out w/ 8 1/2" bit to TD of 7200' md and run 5 1/2" casing to TD (per original permit). Change BHL and LTP from 330' FSL of sec 21, to 100' FSL of sec 21 (amended C102 attached) per the new horizontal well rules. Run pkr and port completion system w/ two pkr elements inside shoe of 9 5/8" csg for annular seal and 5 1/2" will not be cemented.




