5. CUT AND PULL APPX. 1,050' OF 5 1/2" CSG, SPOT 100' PLUG @ 1,100'. TAG.
6. SPOT 100' CEMENT PLUG FROM 450' - 350'. TAG.
7. SET 20 SX CEMENT SURFACE PLUG & INSTALL DRY HOLE MARKER.
