Circ 155 sks of cmt to the pits. Test BOPE to 5000# & Annular to 3500#. At 5:00 A.M. 08/28/18, tested csg to 1500#, held OK. FIT test to 10.5 PPG EMW. Drilled out with 12 1/4" bit.
