4/17/06 - Released pkr. POOH. RIH w/ tbg. Tagged plug @ 996'. POOH w/ tbg. Perf 7" csg @ 512'. Set 7" pkr @ 248'. Sqz 50 sx cmt. CWI. WOC 4 hrs. Released pkr. POOH w/ tbg & pkr. WIH w/ tbg. Tagged plug @ 462'. Spot 20 sx cmt @ 462' - 343'. Perf 7" csg @ 60'. ND BOP & 7" csg head. Install 7 x 2 swedge. Establish circ. Circ 35 sx cmt down 7" csg & up to surface of 8 5/8" csg.
4/18/06 - Opened up well. Cmt @ surface. Dug out cellar. Cut off well head. Install dry hole marker.
