Pressure tested csg, held 500 psi. Spotted 25 sx class C cmt @ 705-334'. WOC. 11/29/18 Tagged plug @ 370'. ND BOP. Perf'd csg @ 175'. Squeezed 30 sx class C cmt @ 175' to surface. Cmt did not circulate through perms, cellar was full of cmt. Plug approved by Gilbert Cordero w/ NMOCD. Rigged down & moved off. Moved in backhoe and welder. Dug out cellar, cut off well head, & verified cement to surface. Welded on "Above Ground Dry Hole Marker". Backfilled cellar, cut off deadmen, cleaned location, and moved off.
