
- 1) MIRU rig 9/4/18
- 2) POOH rods/pump, scan tbg out of hole.
- 3) Set RBP with wireline at 5300' . Perforate Williamson Sand formation from 5128' - 5148' .
- 4) Set packer above perfs, pump 1,500 gal 7.5% HCl. Swab well.
- 5) Rig up for single stage frac 9/11/18. Pump 1,500 gal 15% HCl acid spear, 64,590# 20/40 sand, 16,840# LC resin in 30# x-link slurry. Flush with slick water.
- 6) Unset packer, POOH tbg, RIH production equipment and turn back on to production 9/13/18.
