- Removed equipment, debris, and building from location
- Removed historically impacted soils surrounding well head to approved disposal facility
- Flipped clean caliche soils from the former well pad and the former lease road
- Contoured native and clean imported topsoil to the surrounding landscape
- Re-seeded the entire site with Lesser Prairie Chicken BLM seed mix
- Installed a berm across the former lease road entrance to prevent traffic disturbance
