Mixed @ 14.8#/g w/1.35 yd. Displaced w/64 bbls of FW. Plug down @ 2:30 AM 10/10/18. Did not circ cmt. Lift pressure @ 90# @ 3 BPM. Ran temp surv indication TOC @ 160'. TIH 1" pipe. Tagged @ 125'. Ran 1" pipe in 17 stages with 742 sks Class C w/4% CaCl2. Mixed @ 14.2#/g w/1.61 yd. Circ 25 sks of cmt to the cellar. Test BOPE to 5000# & Annular to 3500#.
