The intermediate shoe is at 4363?. Isolation Scanner Cement Evaluation Log shows the TOC to be 4160?. After running the cement evaluation log we pressure tested the 5-1/2" x 9-5/8" annulus to 900 psi. The pressure held steady with minimal bleed off indicating that we have good isolation. Attached is the Isolation Scanner Log and test chart from the 5-1/2" x 9-5/8" annulus pressure test.
