



DIRECTIONS TO LOCATION


From the intersection of CR-725 (Longhorn Rd.) and CR-725A (Tarbrush Rd.)
Go Northeast on CR-725 approx. 0.5 miles to a curve to the left;
Turn left and go Northwest approx. .5 miles to a curve to the right;
Turn right and go Northeast approx. 1.2 miles to a lease road on the right;
Turn right and go East approx. 1.2 miles to a proposed road;
Continue East on proposed road approx. 0.1 miles to proposed road right;
Turn right and go South approx. 380 feet to proposed road right;
Turn right and go West approx. 620 feet to location on the left.
