Adjust pad contour as necessary to blend with surrounding landscape.

Address erosion issues on west edge of pad, west of the N-S pipeline riser access road.

Rip pad and reseed with BLM Mixture 4 (Gypsum blend) at a mixture of Alkii Sacaton (*Sporobolus airoides*) 1.5 lbs/acre (2.7 lbs total) and DWS (De Winged Seed) Four-wing Saltbrush (*Artiplex canescens*) 8.0 lbs/acre (14.5 lbs total).

Reseeding will be done by disking. The initial disking will run generally N-S and the second pass will run generally ENE-WSW to be perpendicular to the slope.

The pad and the immediate surroundings will be inspected for noxious or invasive weeds. Any found specimens will be removed.

The road running N-S will be left intact for pipeline riser access and grazer use.
