Circ 79 sks of cmt to the pits. Test BOPE to 5000# & Annular to 3500#. At 12:00 P.M. 08/04/18, tested csg to 1500#, held OK. FIT test to 10.0 PPG EMW. Drilled out with 12 1/4" bit.
