


OCD Well Locations

- 1) Statement that if this is not approved your other alternatives such as flare etc. as these wells are oil producers.

If this application is denied, Mack Energy would be forced to either flare 1200mcf per day. The other alternative would be to cancel drilling these leases Oil-2000 barrels per day, Gas-1200 mcf per day, in hopes that DCP would install pipelines.
