RIH & set 7-5/8" 26.4# L-80 BTC csg @ 11292', DVT @ 4494', ACP @ 4511', pump 80bbl mudpush spacer then cmt w/ 751sxs (341bbl) class C w/ additives 10.2ppg 2.55 yield followed by 175sxs (52bbl) class C w/ additives 13.2ppg 1.61 yield, no returns. Inflate ACP to 2000#, open DVT, circ thru DVT, 20sxs cmt to surface. Pump 2nd stage w/ 50bbl brine water spacer then cmt w/ 1476sxs (472bbl) class C w/ additives 12.9ppg 1.73 yield. Full returns throughout job, circ 551sxs cmt to surface. 2/14/19 WOC, install nightcap and rig release.
