Inflate ACP to 2000#, open DVT, circ thru DVT, 20sxs cmt to surface. Pump 2nd stage w/ 50bbl brine water spacer then cmt w/ 1476sxs (472bbl) class C w/ additives 12.9ppg 1.73 yield. Full returns throughout job, circ 551sxs cmt to surface. 2/14/19 WOC, install nightcap and rig release.
