Due to the current production rates of the wells producing to the battery, a second LACT unit is needed to transport oil from the tanks into the pipeline. This second unit will be a second FMP for the facility; both units will be operating simultaneously.

The additional unit will be a Coriolis metering system, installed and proven per 43 CFR 3174. BLM will be contacted prior to proving.

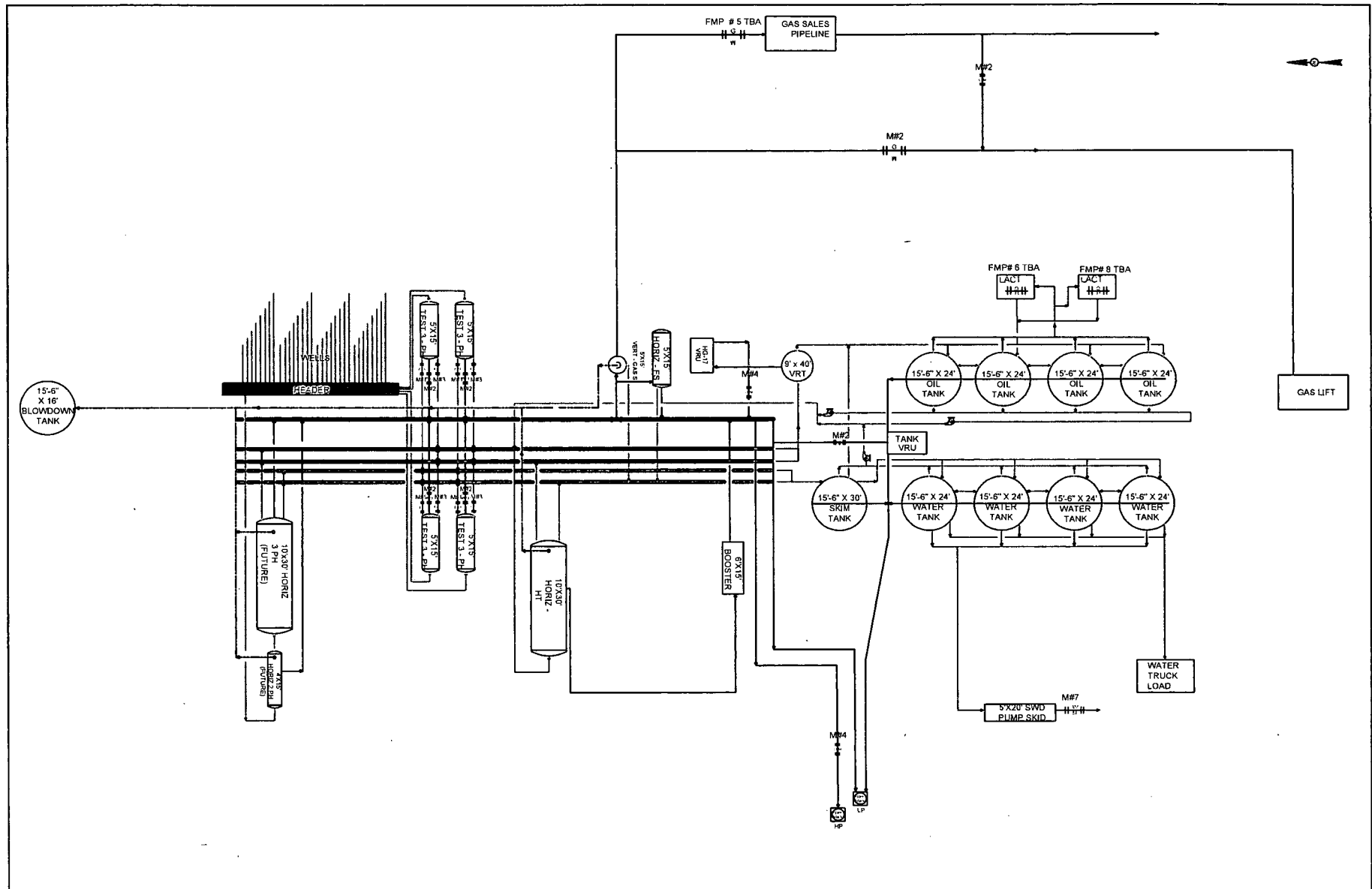
