2-13-2019 - Moved in and rigged up pulling unit and wireline equipment. Closed manual frac valve. Bled well down. Nipped down production tree and nipple up wireline BOP and lubricator. Bled well down. Opened manual frac valve. RIH with wireline with gauge ring and junk basket. TOOH with gauge ring and junk basket. Made up bottom hole assembly string and RIH with tubing with pump out plug, packer and gas lift valves. Set packer at 8800' and tubing at 8806'. Rigged down wireline. Nipple down manual frac valve and nipple up 5K BOP. Shut well in.

2-14-2019 - Circulated hole with 200 bbls of packer fluid down casing. Confirmed that pump off plug popped. Shut well in.

2-15-2019 - Rigged up slickline. RIH with slickline and set PX plug in 2.31" X profile at 8806'. RIH with prong on slickline and set prong in plug. Pumped 32 bbls of packer fluid down tubing and pressure tested tubing to 1500 psi, OK.

Loaded casing with 86 bbls packer fluid and pressure tested casing, OK. Pulled prong out to equalize pressure between casing and tubing. POOH. RIH with overshot and latched onto plug. POOH. RIH with tools to ensure tubing and packer free of obstacles. POOH and rigged down wireline. Landed tubing. Nipped down BOP. Nipped up production tree. Rigged down and moved out pulling unit. Well is now on gas lift.
