- MIRU all safety equipment as needed. POOH with production equipment.
- RIH with GR/JB to 2840 ft.
- Set a CIBP at 2820 ft with 35 ft Class C cement. Pressure test casing. This will place a plug over the open perforations.
- Run Gyro Survey from CIBP up to Surface.
- Tag TOC and load the hole with plugging mud.
- Perforate 5-7/8 inch casing at 1320 ft.
- Squeeze a 55 sx Class C inside/outside cement plug from 1220 ft - 1320 ft.
- Perforate 5-7/8 inch casing at 590 ft.
- Squeeze a 310 sx Class C inside/outside cement plug from 590 ft up to surface.
