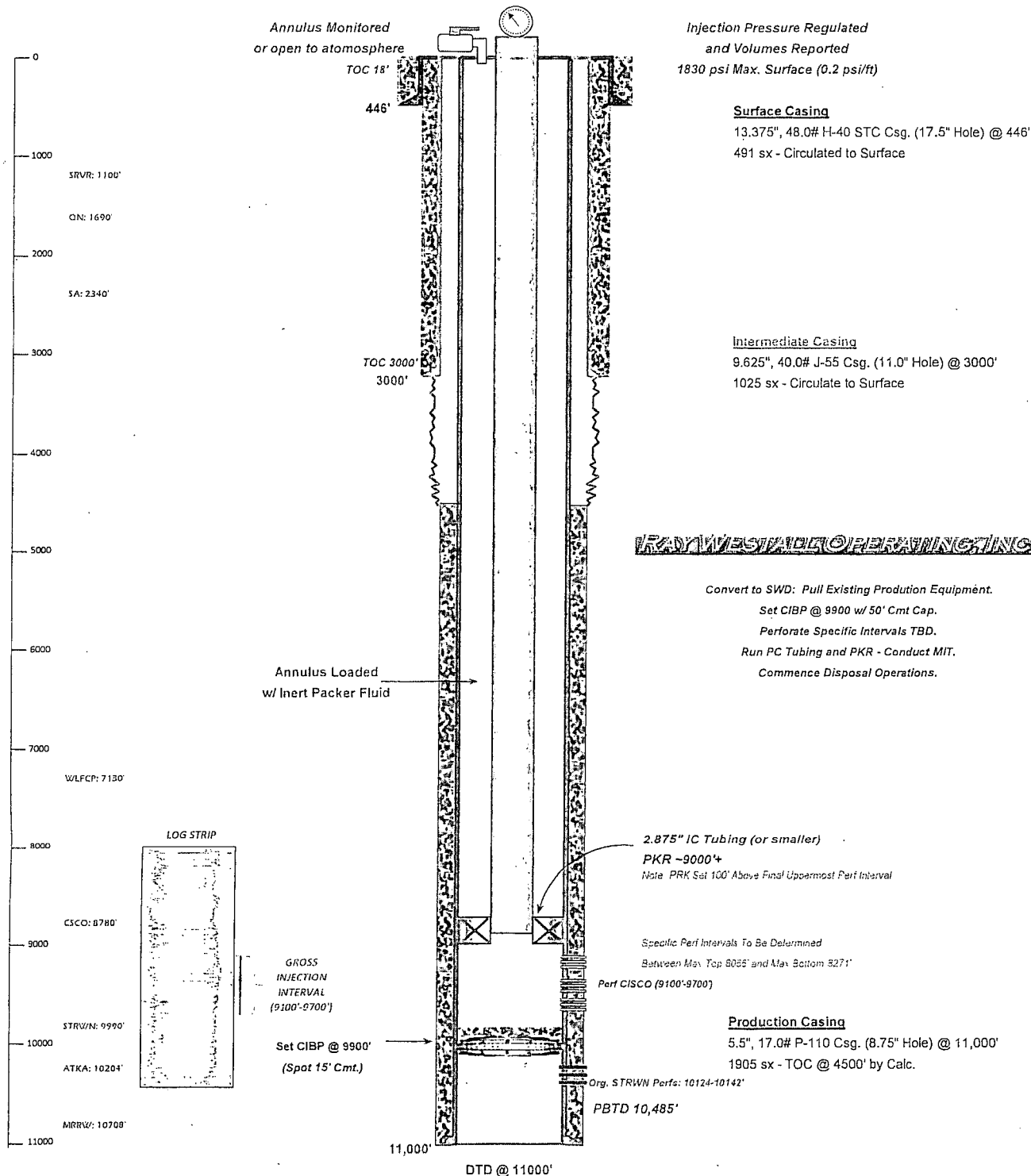
# WELL SCHEMATIC - PROPOSED Empire Deep 29 Federal Well No.2 SWD
