Stage 1: 360 sxs Class C lead cmt and 300 sxs Class C tail cement. Bump plug. Open DV tool. Pump Stage 2: 680 sxs Premium TXI cmt and 140 sxs tail Premium C. Bump plug. Circ. cmt to surface. Test casing to 1850 psi, 30 mins (good).
