Plug down @ 12:30 PM 08/09/19. Circ 97 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 8:00 A.M. 08/10/19, tested csg to 1500# for 30 minutes, held OK. FIT test to 10.5 PPG EMW. Drilled out with 12 1/4" bit.

08/10/19 TD 12 1/4" hole @ 1031'. Ran 1016' of 9 5/8" 40# N80 LT&C Csg. Cement 1st stage with 150 sks Class C w/additives. Mixed @ 12.5#/g w/2.11 yd. Tail w/200 sks Class C w/1% CaCl2.
